WARRANTY TERMS DENIM PHOTOVOLTAIC MODULES

1. Limited product warranty: FIFTEEN (15) year repair, replacement or refund remedy

Denim warrants that for fifteen (15) years from the date of delivery its Photovoltaic modules (PV modules) shall be free from defects in materials and workmanship under normal application, installation, and use and service conditions, according to Denim installation manual and safety instructions. If the PV modules fail to conform to this warranty, then for a period ending fifteen (15) years from date of delivery to the original end-customer (the customer), Denim will, at its option, either repair or replace the product, or refund the purchase price as paid by installer. The repair, replacement or refund remedy shall be the sole and exclusive remedy provided under the Limited Product Warranty and shall not extended beyond the fifteen (15) year period set forth herein. This Limited Product Warranty does not warrant a specific power output, which shall be exclusively covered under clause 2. hereinafter (Limited Linear Power Warranty).
